RE California will use the Rapattoni software. Once the roll out is complete, RE California plans to expand its service to non-Rapattoni MLS customers.

"This marks a major milestone in how MLSs are working together to improve real-time data delivery that further enhances the ability of real estate professionals to more effectively and seamlessly serve their clients," said Bill Miller, CEO of MetroList Services, Inc.
